The undersigned MARE OWNER and STALLION OWNER agree to breed the following mare to the stallion **Macs Blue Erin** in the 2007 season:

The undersigned mare owner and stallion owner confirm their agreement as follows:

- Only stated mare is to be inseminated with the shipped semen. This agreement is non-transferable. The mare owner may not substitute another mare for breeding without prior written consent of Crowndale Farm.
- The mare owner shall pay the stallion owner, upon execution, the sum of \$ 250 as a booking fee, which is non-refundable.
- In addition to the booking fee specified above the mare owner promises to pay the stallion owner the sum of \$ 750 as a service/stud fee paid no later than seven days prior to the collection of semen.
- The mare owner agrees to have a current uterine culture taken when the mare is in heat and submitted to a recognized laboratory, proving the mare to be in good breeding condition and free of infection. Stallion owner is under no obligation to cover a mare, which is deemed to be in unfit breeding condition, such determination to me made at the sole discretion of the stallion owner.

- The stallion owner only assumes responsibility to ship fresh, chilled or frozen semen in viable condition at the time of shipping to the mare owner's veterinarian. The stallion owner assumes no responsibility for loss of semen viability or associated expenses due to any delay in shipment, delay in airline schedules, delays in courier service or other circumstances beyond the stallion owner's control.
- All semen collections and FEDEX shipments are to be paid to the stallion owner's veterinarian. The mare owner will be directly billed for the charges.
- The signing of this contract entitles stallion owner to assess all accounts 30 days past due a finance charge of one and one-half percent (1.5%) per month.
- Only a licensed veterinarian is to do the reproductive exams, handling of semen and insemination of said mare.
- In the event that the mare aborts or fails to produce a foal that stands and nurses without assistance after foaling, the mare owner shall be entitled to have the mare re-bred the following season, 2008, at no additional service/stud fees provided that the stallion owner is notified by the veterinarian by fax within seven days.
- In the event the mare is sold, all fees shall immediately become due and payable and no refund shall be paid under any circumstances and the contract shall become null and void thereafter.
- In the event that the stallion should die or become unfit for service, then the stallion owner will refund only the service/stud fee and the contract shall become null and void provided mare owner chooses not to breed the mare to another of the stallion owner's stallions.
- This agreement constitutes the entire agreement between the parties.
- This contract shall be entered into the state of Texas, and will be interpreted and enforced under the laws of that state.
- This agreement may be executed in one or more counterparts and shall become effective on the date set forth herein. All executed counterparts each shall be deemed to be one and the same instrument.

This agreement shall become null and void unless mare owner returns two executed copies of this agreement together with the above mentioned booking fee. The mare owner should also return a copy of the mare's registration certificate complete with markings.

We hereby agree to the terms and conditions as set forth in this contract dated the _____ day of _____, 2007.
